SESSION OVERVIEW:

Water and its conservation have been topics of debates, negotiations and disputes for many centuries. National and global institutions have established their own laws and regulations, signed agreements and made commitments to help face these challenges.

UN-Water, an inter-agency mechanism formally established in 2003 by the United Nations High Level Committee on Programmes, was created to promote, amongst other things, cooperation and partnership among the UN agencies responsible for global and regional water initiatives.

However, despite the numerous initiatives and events organized by UN-Water, it has been difficult to reach a general consensus on issues related to water resources management. In most cases, the parties involved agree on a set of general recommendations and non-binding plans of action.

Global water governance - and more specifically integrated water resources management - needs to be designed in such a way that it helps identify and address current challenges resulting from the impacts of climate change and other emerging issues related to water resources.

It is necessary to seek a conceptual and operational integration of water initiatives and water management, in particular, coupled with measures that can bring institutional capacity-building and autonomy to the UN-Water system.

This panel could be key to formulating concrete recommendations to address the issue of water governance. Furthermore, the conclusions of this panel could also contribute to discussions to be held during the Rio+20 conference.
